# XACT – changes of fund rules in exchange-traded funds

Xact Kapitalförvaltning will be changing the fund rules for the following funds on January 20, 2017 in accordance with the summary below. However, the funds' character, investment focus and risk level will not be changed due to the enhanced investment opportunities. A number of clarifications and modifications to wording have also been made in addition to the changes described in the summary.

### **XACT OMXS30 and XACT OMXSB Utd**

#### Investment focus

Enhanced to permit the fund to invest in fund units, money market instruments and in an account. Permitted underlying assets to derivative instruments are specified.

# • Specific investment focus

Enhanced to provide the opportunity to invest in unlisted securities, money market instruments and derivatives as part of the investment focus. Also permitted to use techniques and instruments to create leverage. The aim is to attain a more effective asset management, although this will not change the risk level in the fund.

# • Markets

The fund is permitted to trade on MTFs and similar market places.

# • Investment focus

Enhanced to permit the fund to invest in fund units, money market instruments and derivatives. Permitted underlying assets to derivative instruments are specified.

# • Specific investment focus

Enhanced to provide the opportunity to invest in unlisted money market instruments and derivatives as part of the investment focus. Also permitted to use techniques and instruments to create leverage. The aim is to attain a more effective asset management, although this will not change the risk level in the fund.

# Markets

The fund is permitted to trade on MTFs and similar market places.

Enhanced to provide the opportunity to invest in unlisted securities and money market instruments.
